Our forestry machinery pool and software will assist us in the professional management of our woodlands. Our local timber marketing and internet sales have created local employment and is adding value to our timber.

The Society is pleased to announce that it has employed a qualified forester Ms Meike Siebel, to oversee the growing work load.

The Inventory Project of the Donegal Woodland Owners Society Ltd.

Background

The DWOSL has committed to facilitate an ongoing inventory of members' timber which is approaching thinning or harvesting stage. Initiated by a successfully finished 90 ha inventory project during a diploma thesis (a summary is available in the Spring Newsletter 2009) under assistance of TEAGASC and the University of Applied Forest Sciences, Rottenburg, Germany. This current inventory project is part funded by Donegal Local Development Company ("DLDC").

Objectives

This financial support together with funds and voluntary support from Donegal Woodland Owners Society Limited ("DWOSL") and its members will be used towards educating and thereby empowering the private woodland owner to:

- understand how and why a regular inventory is beneficial to forest management
- practically equip him/her with the necessary skills (e.g. how an inventory is carried out, when is the right time to carry it out, how to interpret the results)

Investment has been made into necessary equipment, including height and diameter measurement tools, safety equipment and a geographical information system (GIS), which is used to store the assessed data and update existing maps for more efficient management.

The DWOSL is now employing a registered forester. The forester's responsibilities in this project include:

- finding suitable forest stands that are close to first thinning age (see Table 1)
- assessing the growing stock and the amount of timber which could be harvested during a first thinning according to general Irish practices.
- putting the assessed data into a GIS for presentation and administration
- providing the forest owner with key figures of his/her forest stand to base management decisions on, such as mean annual increment, common annual increment and yield class of the site.

Implementation

The Inventory is now in full progress. Measurement equipment has been purchased and field visits are ongoing to forest stands, some where the forest owner is unsure if his/her woodland is ready or suitable for thinning/inventory. This can be verified by the owner themselves using the proposed statements (table 1):

Within the scope of this inventory project an introduction to "Inventory and Thinning practices and procedures for private woodland owners" will be given on Saturday, 19th

September 2009. This seminar is open to all members as well as all other interested woodland owners in Donegal.

First general practices and procedures are explained in an open classroom setting, with emphasis on their practical application and understandability, followed by a practical field excursion in the afternoon, where forest owners get a hands on experience in measuring tree volume. Furthermore the machinery and wood processing equipment of the Donegal Woodland Owners Society Ltd is presented.

A summary of the inventory results will be given at a separate event in late October (see Homepage for details: www.donegalwoodlandowners.com).
